First response in the event of stowaway discovery



Preambule

This document aims to provide Masters and ship's crews with general guidance in the event of the discovery of one or several stowaways on board a ship. In such a case, the Master should, and in the following order:

- o If possible, assign at least two crewmembers to the stowaway as watchmen;
- Search the stowaway for identity documents and belongings and confiscate anything but the stowaway's clothing;
- Provide the stowaway with basic food, water and immediate medical care;
- In the event more than one stowaway was discovered, separate them in as small of groups as possible;
- Search the vicinity of where the stowaway was discovered for other stowaways;
- Prepare a cabin for the stowaway, removing anything that could be used as a weapon (i.e. bathroom mirrors, soda bottles, etc.);
- Keep the stowaways in the prepared and locked cabin, appointing 24/7 watchmen;
- Instruct the watchmen not to speak to the stowaway unless absolutely necessary (i.e. for toilet use, food, etc.);
- Do not put the stowaway to work for any sort of task;

The above steps are measures of paramount importance in ensuring the crew's and stowaway's safety. As soon as possible, the Master should contact his office or the NNPC for situation-specific guidance. We kindly ask to, as soon as circumstances allow you to, fill out the below stowaway questionnaire and send a filled in copy thereof, with attachments, to claims@nnpc.nl.


